



WHEN IS A PERMIT REQUIRED? CITY OF FATE BUILDING INSPECTIONS DEPARTMENT

The following is a list of projects for which a **PERMIT IS REQUIRED**:

- Accessory building (including permanent and portable storage sheds, gazebos, carports, patio covers).
- Additions to a building
- Air conditioning system installation or replacement
- Deck construction or replacement when more than thirty (30") inches above grade
- Demolition of a building
- Driveway installation or replacement (including circular driveways)
- Driveway approach installation or replacement (approach is the portion of the drive connecting to the street)
- Electrical work (such as replacing switches, plugs and ballasts is exempt)
- Fence construction, repair, or replacement
- Furnace installation or replacement
- Foundation repairs
- Irrigation systems (lawn sprinklers)
- Plumbing work
- Remodeling of a building requiring the addition or replacement of walls or windows
- Retaining wall construction or replacement over four feet in height (measured from the bottom of the footing to the top of the wall)
- Roof replacement
- Solar Panel installation or replacement
- Spa construction (self-contained portable plug-in type spas require electrical permit and shall comply with safety glazing requirements, Chapter 24 of 2003 IBC)
- Swimming pool (above-ground) construction (less than 24 inches is exempt)
- Swimming pool (in-ground) construction, repair, or filling-in
- Water heaters (replacing or adding)
- Water softeners or filtration installation
- Water or sewer line replacement (repair work such as exchange of washers and faucets is exempt)

The following is a list of projects for which a **PERMIT IS NOT REQUIRED**:

- Concrete not more than thirty (30") inches above grade or NOT supporting a vertical load
- Fixture replacement if there's existing wiring or plumbing
- Painting, papering, tiling, carpeting, cabinets, countertops, or similar finish work
- Portable heating equipment
- Portable ventilation equipment
- Retaining walls less than four (4') feet in height measured from the bottom of the footing to the top of the wall
- Wood decking not more than thirty (30") inches above grade or NOT supporting a vertical load
